Potential Election Outcomes and Strategic Implications

Unified Democratic Control

Unified Democratic control would allow a President Harris to swiftly confirm her cabinet, judges, and push for the legislative goals of her first 100 days. However, even with unified control, passing legislation through the narrow Democratic majorities in both the House and Senate would leave little margin for error. Any major Democratic legislative goal that does not receive Republican support will require the use of reconciliation to circumvent a filibuster.

Under Democratic control, Congress is likely to prioritize Harris's proposed economic plan, which includes expanding tax credits for small businesses, homebuyers, and families. **Our experts can help you strategize effectively to align with these priorities.**

Unified Republican Control

Unified Republican control would provide a re-elected President Trump and a Republican Congress the opportunity to roll back regulations and legislation enacted during the Biden administration.

Republicans would also be in a strong position to renew and expand the 2017 Tax Cuts and Jobs Act (TCJA) and renew the USMCA trade deal. Under unified control, Republicans would have the ability to quickly confirm Trump's cabinet and judicial nominees. Divided Congress with a Democratic White House

If Democrats retain the White House but fail to gain control of one or both houses of Congress, it will be difficult for any legislation to pass without bipartisan support. A Republicancontrolled Senate would likely block any of President Harris's cabinet and judicial nominees deemed too extreme. If Republicans retain the House, much of Harris's legislative agenda would likely stall. Either house under Republican control would launch Congressional investigations against a Harris administration.

With the 2017 Trump tax cuts expiring next year, President Harris could use her potential renewal as leverage to negotiate the inclusion of her tax credit proposals with a Republican-led House or Senate. **Our team can help navigate these complexities and facilitate effective engagement with key policymakers.**

Divided Congress with a Republican White House

If former President Trump wins the White House but Republicans fail to secure one or both houses of Congress, it would lead to legislative gridlock and create a politically difficult situation for the administration.
